JANA VIKAS AT A GLANCE:

JANA VIKAS is a secular, voluntary and non-profit making organization registered at district level under the Societies Registration Act (SRA), vide Reg. No - 2641-39, 1991-92 on dated 6th May 1991. Again it was reregistered under IGR Cuttack, Odisha, vide Reg. No - 22276/04 of 2006-07, on dated 13th April 2006. It is also registered under the Foreign Contribution Regulation Act (FCRA) of 1976 vide registration No. 105030001 on dated 16th September 1992, Ministry of Home Affairs, New Delhi, Government of India.

In Odia language "JANA" means 'People' and "VIKAS" means 'Development'. It is evolving as capacity building organization and has also partnered with various NGOs and Govt departments and have formed consortium at different levels to address issues at District, State and National level. Presently, the organization is working in 3 districts, 11 blocks, 46 Gram Panchayats and 469 villages. The focus is still on marginalized Dalit, indigenous tribes, minority and other backward communities.





The organization has clear strategic plan for the year 2018-2023. The thematic areas are Livelihood, Education, Governance, Women Empowerment and Violence against Women and Peace Building and Disaster Response. The organization has also policies which are providing better governance in terms of transparency and accountability. Human Resource (HR), Finance, Gender, Child Protection, Anti-Sexual Harassment, Safeguarding Disability, Environment Protection and Contingency policies are mandatory to be practiced by all the stakeholders associated with the organization.









JANA VIKAS LOCALIZING SUSTAINABLE DEVELOPMENT GOALS:

Jana Vikas strives to reach to the unreached communities focusing the Sustainable Development Goals through various intervention of different implemented projects. Interventions, implementation and achievements are highlighted under thematic SDGs to segregate various efforts and engagement in the community.





No Poverty & Zero Hunger

The concern of the whole world is to eradicate poverty and hunger in the lives of people to see the development of society dignity through various implementation of programs, project, schemes and initiatives from village level to international level.

Jana Vikas in its own way through different engagement in the community try to enhance sustainable livelihood of the communities. It was an opportunity for Jana Vikas to facilitate and implement two Odisha State Government program such as Odisha Millets Mission (OMM) and Special Programme for Promotion

A. Odisha Millets Mission

Odisha Millets Mission is a flagship programme launched by Department of Agriculture & Farmers Empowerment, Odisha with the intention of reviving millets in rain fed farming systems, household consumption and marketing. This will promote production which slowly in verge of endanger situation, increase the consumption nutritional value providing and food sustaining security and sovereignty.
































In this reporting year total 398 farmers of total village 43, 08 Gram Panchayats in G. Udayagiri block of Kandhamal district have adopted Millet cultivation on their 186.8 Hq land. The farmers have adopted scientific method of cultivation to increase their millet production. 76 farmers have adopted Systematic Millets Intensification method on their 37.5 hectares land and 322 farmers have adopted Line Transplantation method on 148.8 hectares land.



Jana Vikas organized regular orientation camps of millet on Systematic Millet Intensification method, Bio-fertilizer preparation and application, pest and disease management, seed selection and storage, etc.







This year 756 quintals of millet from 151 farmers in G. Udayagiri block has been procured through government procurement process and Rs. 1303250.00 incentive was received by farmers.

Special Programme for Promotion of Integrated Farming (SPPIF).

Jana Vikas was fortunate to implement the SPPIF project in Kotagarh block of Kandhamal district. The focus of this project by Government of Odisha is to implement "Special Programme for Promotion of Integrated Farming" (SPPIF) to enhance the income and food security of the tribal families with the component of integration of different production systems such as Agriculture, Horticulture, Livestock, Fisheries, Agro-forestry through integration



of various convergence schemes. Directorate of Agriculture & Food Production (DA&FP) is the state level nodal agency and ATMA is the district level nodal agency and NCDS & WASSAN are the technical agencies to support. Jana Vikas as the Facilitating Agency and PIPADI, EPO and implementing the project at cluster level 12 GPs.



Jana Vikas has initiated this program in four GPs- Kotagarh, Madaguda, and Durgapanga Judabali Kotagarh block in the first phase. The reached project out the communities and farmers through different line departments such as Agriculture, Horticulture, Fishery and Livestock. It also worked with WSHGs in collaboration Mission Shakti and Odisha Livelihood Mission (OLM).

Under Agriculture

247 farmers cultivated black gram in **100 Hac** of land and **Rs.683449.00 received incentive**. One Mini Seed Centre was established at Madaguda and One Unit of Liquid Manure Centre was given to WSHG to promote the organic manure in the block.

Under Horticulture

210 farmers are supported materials for vegetable cultivation in trellis method in 210 Acre and received Rs.718200.00. Support for Micro Irrigation System promoted and in 42 Acre by providing 42 farmers sprinkler and pipe; Support for Vegetable cultivation, supply of seed/sapling were provided to 84 farmers and Rs. 84000.00 received incentive and Agro-forestry Model/Adarsha Bagicha was developed by 42 farmers in 42 Acre.































275 farmers were supported for construction of Goal Shelter and those farmers received incentive Rs. 1128050.00. 3 Indigenous Chicks Production Unit were established to promote the indigenous chicks. 1000 Poultry Night Shelter were supported to the farmers to rear the chicks. 7 farmers were provided for Backyard Duck rearing and 25 farmers were given support for developing Azolla cultivation.





Under Fishery

49 farmers were supported for Quality Fish Seed Stocking (Fingerling / Yearling) and in 2 units there was a support for establishment of Nano Fish Feed Mixture Unit.

Livelihood through Social Security Schemes:

Jana Vikas team is making attempt to train communities to access Social Security Schemes and livelihood opportunities from the govt. The team also provide handholding support to link the community members at Panchayat level, Block and District level stakeholders responsible to provide services to these communities. The team makes the communities to understand all the schemes, where to access and how to access. This helps many families to access the entitlements. This further

migration and stay back in villages and to live a sustainable and dignified lives. The initiative has covered 210 villages and almost trained 6216 members.























Facilitating communities to access Labour Card



One of the issues is in district Kandhamal is distress migration. Lack of employment opportunities and poor state of agriculture sector in the remote areas of Kandhamal continue to trigger exodus of human resources almost on a daily basis.

These workers shift to places like Chennai, Bengaluru and Hyderabad in search of jobs. While around 3,000 from Kandhamal have shifted their occupational base to Southern States, their parents

and kids are staying in their native villages. Many a times they meet accidents and unable to get medical treatment privileges in the government hospitals despite the existing policies of the Govt. Mentioned are

some of the reasons a) Many don't have labour cards b) Have cards but have not renewed c) Many don't apply for benefits due to ignorance. This is the reason our community organizers conduct workshop at the village level and help the men, women and youths to understand the usefulness of cards and also provide handholding support to introduce them with labour department and help them either access labour cards or renew them.

However, due to topography and dense forest most of government machineries could not reach people at grass root. Due to these many lack information on basic provisions such as Social Security Schemes (Old age, widow, unmarried pension etc) and alternative



livelihood opportunities. Team members conduct meetings with CVG/ABGG members twice in a month and discuss the privileges they have from the government. Team also provides handholding support to access these benefits. as a result, people have accessed different provisions from various line departments.































SDG - 3 Good Health & Well-Being:

To ensure healthy lives and promote well-being for all at all ages under Goal-3 of SDG, Jana Vikas has been implementing General Health Activities

Community Patshala:

The concept of Community Patshala was evolved in post Covid-19 where community takes the ownership to run, manage and monitor the village education centre for improvement of the education standard of the students.







Child Clubs:

As Jana Vikas is engaged with the children for quality education and protection of child rights in village level, it has formed Child Clubs in each center to discuss about the violence against children in the family, schools and village and try to resolve among themselves and help each other to increase attendance in tuition and schools.

Capacity building of SMC members and PTAs on different issues related to the children and the process to address those issues.

Capacity building of SMC and PTA was organised in different operational area to discuss regarding their roles & responsibilities and to coordinate SMC team to suggest and resolve school related issues as per the RTE guideline. They expressed that Community Patshala programme is impact base program and requested Jana Vikas to continue providing tuition base program in the centers.





















Interface meeting with Teachers and Line Departments:

Jana Vikas has been always working in collaboration and supplementation of government departments efforts to facilitate quality education of children at the village level. With the support of various persons from different departments like Child Line, District Child Protection Unite, Government Teachers and DCPOs of different districts, trainings for Community Patshala Teachers and community members and students have been conducted. The resource persons have highlighted various Govt schemes and provisions for students and children and expressed their full cooperation and suppositions.

As Jana Vikas is engaged in the community sensitizing and capacitating on different government provisions and schemes for proper implementation, it keeps good relationship with PRI members and try to include Child Development Plan, Prevention of Child Marriage, Trafficking, Child Labour Act in the GPDP. It was a big step taken by some of the Sarapanch to include Children Development Plan in the agenda of panchayat meetings.















Training and Interaction with District Welfare Officer on facilitation of Scholarship:



The orientation training has been conducted in three districts- Kandhamal, Gajapati and Bolangir where parents, teachers and Patshala committee members and students were present. The main aim of conducting orientation was to help the schools and college to register their institutions under National Web Portal and asked them to verify on the stipulated level of verification. The required documents have to get ready at student level.

Jana Vikas has been engaged in every year facilitating Pre-Matric, Post-Matric and Merit-cum- Means scholarship for ST, SC and Minority students in Kandhamal district. 376 students were assisted in online application process during the reporting period. The cooperation of District Welfare Officer encouraged us to reach out to many students in accessing scholarship.



























Gender Equality: SDG-5

Progressing gender equality is critical to all areas of a healthy society, so the aim of SDG-5 is to achieve gender equality by ending all forms of discrimination, violence and any harmful practices against women and girls in the public and private spheres. It strips to call for the full participation of women and equal opportunities for leadership at all levels of political and economic decision-making.

Jana Vikas has implementing different women empowerment activities like formation and strengthening of women groups, skill development of girls and women, income generation and economic activities for women groups, prohibition of girl child marriage, child right, and all violence against women since its inception. Formation and strengthening of women and adolescent girls' groups are the priority to capacitate and address the issues of the community. The Domestic Violence cases are being referred to District Women Support Service Cener, Kandhamal.





This will also link to the Govt. machineries and information will be disseminated at the administration level.

Training was conducted at 110 villages with CVG, community members, Self-Help Groups

Community Vigilance Group (CVG) was formed in each village. The CVG is comprised of members from various village level institutions and leaders as mentioned below in the table. This strategic change will bring more vibrancy and accountability at the village level. People will participate and own up the program.

and children. The project team briefly discussed about current context and violation of child right, importance of POCSO Act, address issues of atrocities and domestic violence. Most of the parents are either illiterate or semi-illiterate, thus, they are ignorant about importance of education. They have enrolled children in the schools, but they keep them engaged in household work either to take care of siblings or domestic/farm works. Due to frequent absenteeism in the school, they are unable to cope up with the syllabus in the schools and gradually in higher classes drop out and engage as child labor even


if they continue schooling the quality of education is so low that, they are unable to compete with mainstream children and unable to get good Jobs and forces to work as unskilled/daily wage workers and remain poor. Some of the children indulge

in consuming alcohol and substance abuse. Thus, the project team striving hard to explain the four rights at the village level. Right to Survival-The communities are informed to access various benefits of


the government such as early child hood education, Ready food, clothes, Mid-day meals in the schools, educational facilities etc., Right to Protection-Requesting communities to send the children to schools instead of engaging them in work in school hours, discouraging child labor, mentoring them to not to indulge in consumption of alcohol and substance abuse, Prevent from child marriages. Right to Participation—Children should be allowed to take some decisions at homes and village; they should be allowed to participate to organize village festivals and social cultures. Right to Development-Communities to



access hospitals for safe delivery, regular immunization, nutritional and health services for pregnant and maternal mothers and encouraging children to attend Anganwadi centers to get education, encouraging attending school regularly and completing the task given, access regular mid-day meal, avail PDS benefits, Adolescent girls to attend trainings sports and quiz events etc.




